## 1. YOUR RIGHTS AS A REGISTRANT

As a domain name registrant, you have specific rights guaranteed by ICANN:

- Accurate Information: Your domain name registration must be maintained by an ICANN-accredited registrar.
- Access to Terms: You have the right to receive clear and accurate information about the terms and conditions of your registration.
- Transfer Rights: You have the right to transfer your domain name to another registrar in accordance with ICANN policy.
- Privacy: You have the right to information about how your personal data is used and protected.
- Customer Support: You have the right to receive support from your registrar for domain-related issues.
- Renewal Notification: You have the right to be notified before your domain name expires.

## 2. YOUR RESPONSIBILITIES AS A REGISTRANT

In exchange for these rights, you agree to fulfill certain responsibilities:

- Accuracy: You must provide accurate and reliable contact details and promptly correct any errors.
- Updates: You must update your contact information within seven \((7)\) days of any change.
- Compliance: You must comply with all applicable laws and registry policies.
- Security: You are responsible for maintaining the security of your account and authorization codes.
- Payment: You must pay all fees associated with your registration and renewal on time.
- Legal Use: You must not use your domain name for illegal

activities, including spam, malware distribution, or intellectual property infringement.
